

NOTICE OF RENEWAL OF LICENCE

Section 135, Sale and Supply of Alcohol Act 2012

To WILSON LIQUOR GROUP LILIMITED

The Off Licence in respect of the premises situated at 40 Leach Street NEW PLYMOUTH 4310 and known as Super Liquor New Plymouth is renewed.

The present conditions of the licence continue to apply.

OFF-LICENCE

Sections 17 to 20, and 64, Sale and Supply of Alcohol Act 2012

033/OFF/352/2017

Pursuant to the Sale and Supply of Alcohol Act 2012 (the **Act**), **WILSON LIQUOR GROUP LILIMITED** (the licensee) is authorised to sell alcohol on the premises situated at 40 Leach Street NEW PLYMOUTH 4310 and known **SUPER LIQUOR NEW PLYMOUTH**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

If this licence is not endorsed under section 40 of the Act, the licensee is also authorised to sell alcohol on or from the premises and deliver it somewhere else.

This licence is subject to the following conditions:



Conditions

The OFF LICENCE be renewed for three (3) years from the date of expiry 5 October 2024.

No alcohol is to be sold or delivered on Good Friday, Easter Sunday, Christmas Day, or before 1pm on Anzac Day.

Alcohol may be sold only on the following days and during the following hours:

Monday to Saturday 9:00am to 9:30 pm

The licensed area of the Off Licence for the sale of alcohol is limited to the floor area within the BOTTLE STORE as marked on the plan date stamped 30 August 2024.

A properly appointed certificated or Acting or Temporary Manager must be on duty at all times, within the licensed area, when the premises are open for the sale and supply of alcohol and their full name must be on a sign prominently displayed in the premises.

The ENTIRE BOTTLE STORE is designated SUPERVISED.

Drinking water is to be freely available to customers, while alcohol is being supplied free as a sample on the premises.

The licensee must ensure that the provisions of the Act relating to the sale and supply of alcohol to prohibited persons are observed and must display appropriate signs adjacent to every point of sale detailing the statutory restrictions on the sale and supply of alcohol to minors and the complete prohibition on the sales to or intoxicated persons.

Duration

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licences, this licence expires on:
